The Certified SC Seafood program is a cooperative effort between the SC Department of Natural Resources and the SC Department of Agriculture to brand and promote South Carolina Seafood. Our goal is for consumers to easily identify, find, and buy Certified SC Seafood. Commercial fisherman, shellfish harvesters, and aquaculture farmers who commercially catch, harvest, or farm seafood in South Carolina waters are eligible to apply for Certified SC Seafood membership and use the Certified SC Seafood logo on their products. The Certified SC Seafood program is free to join! Membership is made by application to and acceptance by the SC Department of Agriculture Marketing Department.

Certified South Carolina Program Terms and Agreements

Through my signature below, I acknowledge that I have read and agree to the following terms during the application process and throughout my participation in the Certified South Carolina Program:

The Certified SC Grown, Certified SC Product, and Certified SC Seafood logo symbols shall only be used on products identified herein and kept on file with the South Carolina Department of Agriculture. Alterations made to any identified products will require re-application for permission to use the logo. Applicant understands this request is for the use of the Certified SC Seafood logo on labels or packaging of South Carolina Seafood that is grown or harvested in SC or on any seafood product that is landed at a South Carolina dock only. Applicant agrees to only utilize the logo on top quality products. No culls or second quality product may bear the logo. Applicant agrees to immediately discontinue use of logo on items that do not conform to the “Certified South Carolina Program Standards” upon written notification from the South Carolina Department of Agriculture. The South Carolina Department of Agriculture reserves the right to revoke Applicant’s use of the logo at any time use of the logo has been abused. Unauthorized use may also result in liability and prosecution under Federal Trademark Law. Applicant agrees the logo does not constitute any type of endorsement by either the South Carolina Department of Agriculture or the State of South Carolina. The Applicant also agrees to notify the South Carolina Department of Agriculture if sourcing changes in a way that affects your eligibility. Applicant further agrees to abide by the terms and conditions for the reproduction and use of the logo as provided in the “Certified South Carolina Style Manual.”

By signing this agreement you agree to provide source verification to the SC Department of Agriculture and/or the SC Department of Natural Resources for products that bear the Certified SC Seafood logo with either an invoice or bill of laden if requested.
